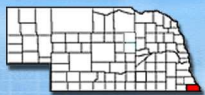

The Board of Equalization recessed for lunch at 12:00 noon and returned at 1:10 p.m.

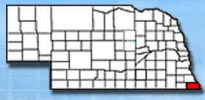
